

Members Committee Two Hundred Twenty-eighth Meeting PJM Conference and Training Center / Webex July 27, 2022 11:15 p.m. – 5:00 p.m. EPT

### Administration

Erik Heinle, Members Committee Chair, welcomed stakeholders to the meeting. He noted that since the Markets & Reliability Committee did not endorse a Market Seller Offer Cap proposal at its July 27, 2022 meeting, Agenda item 2 was removed from the agenda for this meeting.

- A. David Anders announced the following new member companies approved for PJM membership since the last meeting:
  - BARCHART.COM INC. (Associate Member)
  - CPV Retail Energy LP (Affiliate Member affiliate of CPV Power Holdings, LP) selected the Other Supplier sector

He noted that no members had withdrawn since the last meeting and that the total membership stands at 1089. Twenty-four previously withdrawn members await FERC approval prior to their membership being terminated.

3. 2022 PJM Annual Meeting

Michele Greening provided an update regarding the upcoming 2022 PJM Annual Meeting (Part II).

 Notice of Anticipated Section 206 Filing Regarding Operating Agreement Language on Designated Entity Agreements and Notice of Consultation to the Members Committee Related to a Possible Section 205 Filing

Noting that the Office of the People's Counsel for the District of Columbia was a joint filer of a recent 206 complaint at FERC related to this topic, Erik Heinle chose to recuse himself from the chair for this agenda item. Vice Chair Becky Robinson facilitated this agenda item.

Pauline Foley discussed the background and history of the Designated Entity Agreement and its application, including recent stakeholder discussions and a recent related section 206 complaint. She provided notice regarding an anticipated Section 206 filing regarding OA language on Designated Entity Agreements and notice of consultation related to a possible Section 205 filing as follows:

PJM anticipates making a filing pursuant to Section 206 of the Federal Power Act asserting that the Operating Agreement is unjust and unreasonable as it relates to the implementation of Designated Entity Agreements.

In accordance with Tariff, section 9.2(b) and the Consolidated Transmission Owners Agreement, section 7.5.1(ii), PJM hereby provides notice to the Members Committee of a potential filing pursuant to Section 205 of the Federal Power Act to revise the pro forma Designated Entity Agreement set forth in Tariff, Attachment KK.
