#### **Issue Summary**

Settlement of Emergency Load Response and Emergency Energy Charges Problem Statement/Issue Charge Problem Statement brought forward by City of Rochelle Problem Statement/Issue Charge approved at May 12, 2014 Market Settlements Subcommittee Meeting Number of Meetings covering this topic: 5

## 1. Recommended Proposal

The Market Settlements Subcommittee agreed to bypass the full matrix development in favor of a straightforward proposal that includes the effect of load reconciliation data in the settlement of Emergency Energy and Emergency Load Response. The proposal would result in an adjustment to Emergency Energy allocations that use participants' real-time net interchange to consider Load Reconciliation data. The proposal also calls to include participants' recalculated real-time net interchange in the assignment of Emergency Load Response charges. The subcommittee was issued a poll to determine support, with 93% of respondents in favor of including the effect of load reconciliation in the settlement of Emergency Load Response and Emergency Energy.
