Administration

Ms. Suzanne Daugherty and Mr. Dave Anders welcomed the participants, and provided the antitrust and code of conduct announcements.

Endorsements/Approvals

1. Draft Minutes

Minutes of the August 24, 2017 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections or abstentions.

2. PJM Manuals

- A. Mr. Ron Deloach presented proposed revisions to Manual 03A: EMS Model Updates and Quality Assurance identified in the periodic review of the manual.
- B. Mr. Brian Chmielewski presented proposed revisions to Manual 6: Financial Transmission Rights associated with FTR Forfeitures.
- C. Ms. Lisa Morelli presented proposed conforming revisions to Manual 11: Energy & Ancillary Services associated with the implementation of Intraday Offers.
- D. Mr. Joe Hay presented proposed updates to Manual 14A: Generation and Transmission Interconnection Process identified in the periodic review of the manual.
- E. Mr. Mike Herman presented proposed revisions to Manual 14B: Regional Transmission Planning Process regarding CETL procedural changes.
- F. Mr. Ray Fernandez presented proposed revisions to Manual 28: Operating Agreement Accounting associated with the implementation of Intraday Offers.

Following discussion, items 2.A, and 2.C, 2.D and 2.F were **endorsed** by acclamation with no objections and one abstention. Item 2.B was **endorsed** in a sector-weighted vote with 4.26 in favor. Item 2.E was **endorsed** by acclamation with 13 objections and four abstentions.

3. <u>Primary Frequency Response Sr. Task Force (PFRSTF)</u>

Mr. Glen Boyle presented the draft charter for the PFRSTF. Following discussion the committee **approved** the proposed charter by acclamation with no objections and no abstentions.

4. Governing Documents Enhancement & Clarification Subcommittee (GDECS)

Ms. Janell Fabiano and Ms. Jennifer Tribulski presented proposed Tariff, OA and Reliability Assurance Agreement revisions regarding clean-up of definitions and other corrections. Following discussion the committee endorsed the proposed revisions by acclamation with no objections and no abstentions.

5. <u>Balancing Ratio</u>

Mr. Adam Keech discussed Tariff provisions for calculation of the Balancing Ratio used in determination of the Market Seller Offer Cap to be used in the 2020/2021 Base Residual Auction. The committee will be asked to endorse the proposed Tariff revisions at its next meeting. He presented a proposed Problem Statement and Issue Charge regarding the calculation for following BRAs. Ms. Katie Guerry proposed a friendly amendment to delete the first paragraph under the Stakeholder Group Assignment; this was accepted and therefore it was incorporated into the Issue Charge. Mr. Jim Benchek proposed a friendly amendment to replace "MOSC" with "Market Seller Offer Cap" in Key Work Activity 1; this was accepted and therefore it was incorporated into the Issue Charge. Following discussion the approval of the Problem Statement and Issue Charge was deferred to the committee's next meeting to permit further refinement of the documents.

First Readings

6. Distributed Energy Resources Update

Ms. Chantal Hendrzak discussed current status of the Distributed Energy Resource issue and presented a proposed charter to convert the effort to a subcommittee. The committee will be asked to approve the charter at its next meeting.

7. 2017 Installed Reserve Margin Study Results

Mr. Tom Falin reviewed the 2017 Installed Reserve Margin (IRM) study results. The committee will be asked to endorse the study results at its next meeting.

8. <u>Annual Revenue Requirements for New Black Start Units – Phase 2</u>

Dr. Joe Bowring discussed the Minimum Tank Suction Levels (MTSL) proposal developed as part of Phase 2 for the Annual Revenue Requirements for new Black Start units. Ms. Ruth Ann Price had considered moving to adopt the proposal, however withdrew it from deliberation at this meeting.

9. Restoration Planning Generator Data

Mr. David Schweizer presented proposed Operating Agreement revisions associated with PJM sharing of restoration planning generator data with Transmission Owners. The committee will be asked to endorse the proposed revisions at its next meeting.





10. PJM Manuals

- A. Ms. Lisa Morelli presented proposed Manual 11: Energy & Ancillary Services and proposed revisions to the Operating Agreement (OA) associated with capping of intraday offers. The committee will be asked to endorse the manual and OA revisions at its next meeting.
- B. Ms. Melissa Pilong presented proposed revisions to Manual 11: Energy & Ancillary Services associated with the offer verification process and offer capping logic for the implementation of Order 831: Energy Offer Verification. Dr. Joe Bowring, Monitoring Analytics, Ms. Morelli and Ms. Pilong discussed ongoing dialogue between PJM and the Independent Market Monitor regarding some specific details of the proposed Manual 11 revisions. The committee will be asked to endorse the manual revisions at its next meeting.
- C. Mr. Mike Herman presented proposed revisions to Manual 14B: Regional Transmission Planning Process to add information related to the contingency definitions. The committee will be asked to endorse the proposed revisions at its next meeting.
- D. Mr. John Reynolds presented proposed revisions to Manual 19: Load Forecasting and Analysis to clarify when load drop estimates are produced and the required periodic review of the Manual. The committee will be asked to endorse the proposed revisions at its next meeting.

11. Preliminary 2018 Project Budget

Mr. Jim Snow discussed the preliminary 2018 project budget.

12. Capacity Construct / Public Policy Sr. Task Force (CCPPSTF)

Mr. Dave Anders provided an informational update on the activities of the CCPPSTF.





13. Incremental Auction Sr. Task Force (IASTF)

Mr. Brian Chmielewski provided an update on the activities of the IASTF. He reported that the IASTF had recently taken a binding vote on existing Phase 1 proposals in which no proposal received simple majority support. The task force members expressed interest in continuing to work toward development of additional proposals. Following discussions there were no objections expressed to endorsing the IASTF to continue work on development of Phase 1 proposals.

14. Retirement of Yards Creek Special Protection Scheme

Mr. Evan Ferell, FirstEnergy, presented information related to the retirement of the Yards Creek Special Protection Scheme.

15. Retirement of Aurora Energy Center Remedial Action Scheme

Mr. Alan Engelmann, ComEd, presented information related to the retirement of the Aurora Energy Center Remedial Action Scheme.
