May 24, 2017: PC- Cost Containment special sessions started

January 25, 2018: main motion fails vote at MRC, alternate motion presented and vote deferred until May for additional work and discussion of alternate motion

February 9, 2018: PC Special Sessions restarted

May 24, 2018: MRC - vote or request for additional time from special sessions

At the May Planning Committee:

- At stakeholder request, PJM presented both of their proposals and templates.
- PSEG motioned and Exelon seconded a vote on PJM's packages
- DP&L motioned to defer the May MRC vote to August, with PC vote in July to allow for additional discussions and PC vote



- PJM Package 1 passed, 64% in favor
- PJM Package 2 failed, 47% in favor
- Motion to Defer passed, 78% in favor

Motion for PC Recommendation to MRC to Allow More Time for Consideration of Cost Capping Issue

- PC Recommendation to MRC to defer vote on pending Cost Capping Proposal (and remand to PC) until Aug MRC.
- Allow for additional PC Special Sessions past May 11th if necessary
- PC Vote on solution(s) in July
- PJM to prioritize scheduling special sessions as needed
- PC and MRC to be presented with full proposals in matrix form highlighting areas of agreement or disagreement as appropriate.
- First Reads will be provided to both PC and MRC
- Deadlines, Presentations, and Voting will follow M34 guidelines
