1. Service on PJM for Rate and Waiver Filings under Governing Agreements

Steve Pincus reviewed a proposed Problem Statement and Issue Charge addressing service to PJM of Members' Tariff rate and waiver filings under PJM Governing Agreements. Stakeholders offered several suggested updates to the Issue Charge, including the venue and potential scope limitation. Joe Bowring, Independent Market Monitor (IMM), discussed incorporation into the Problem Statement and Issue Charge of notification of the IMM of certain filings. Following discussion, the proposed Problem Statement and Issue Charge were withdrawn to allow consideration of stakeholder comments. PJM will consider holding an education session with stakeholders prior to bringing an updated Problem Statement and Issue Charge to the MRC.

Paul McGlynn presented proposed revisions to the Operating Committee Charter. Following discussion the proposed revisions were **approved** by acclamation with no objections and one abstention.
