### Secure Area Expiration


- Access expiration policy for Members and PJM staff:
  - Access will expire in 3 years
- Access expiration policy for Non-Members:
  - Access granted prior to August 8, 2023, will expire in 1 year
  - Access granted after August 8, 2023, will expire in 2 years
- Notification will be sent before access expires

Area	Action Required
PJM.com secure areas requiring access approval, as well as potentially CEII authorization	Use the renew option to keep access



- PJM is in the process of transitioning to a new interconnection process.
- Services Request section will be redesigned to enable members to interact with the interconnection requests in pre-transition and post transition format.
- Initial phase is scheduled for mid-April release.

- We are working through multiple factors that may contribute to the website delays, specifically:
  - Move Search engine to Cloud Completed in March 2023
  - Move PJM.com and its sub-sites to Cloud In Progress (target completion: March 2024)
  - Upgrade software to the latest version In Progress (target completion: March 2024)
  - Refactor code base In Progress (target completion: December 2024)
  - Measure performance metrics Ongoing
