- ✓ **PJM Primary Focus** – Issuing AD1/AD2 ISAs
- ✓ **AE1-AG1** - Continue to issue agreements as analysis/timing/priority permits
- ✓ **Close AI2 Queue** – Perform deficiency reviews for ~ 500 projects
- ✓ **Transition Preparation**


- ✓ **Execution** of AD1/AD2 ISAs
- ✓ **AE1-AG1** - Continue to issue agreements as analysis/timing/priority permits
- ✓ **Transition Preparation**

(60-day period from Transition Start Date)

- ✓ **Eligibility Period:** AE1-AG1 not in receipt of final agreements prior to transition have 60 days to provide:
  - \$4,000/MW readiness deposit
  - Site control for generating site for one year from transition date

- ✓ **PJM finalize review** deposits/site control and determine cohort of projects to move forward
- ✓ **PJM will update models** based on cohort moving forward into transition
- ✓ **Retool 1:** Retool analysis to determine Fast Track vs. TC1 projects.
- ⌚ **Retool 2:** Retool Fast Track with TC1 projects removed from model.

*Note: LF/SC/Stability models all need to be updated/retool ran prior to being able to issue final agreements in Fast Track.*
