



### **Final Agreement Negotiation Phase Timeline**



Expedited Process Specific Timing

- **OTB Election:** 30 days from receipt of Facilities Study
- Security: due with final agreement execution





**Draft Agreement Process** 

PJM will provide Project Developer (PD) and Transmission Owner (TO) an electronic draft of interconnection agreement.

## $\triangleright$ PD and TO

have 20 Business Days to return written comments.

PJM will have 10 Business Days to respond and provide revised agreements, as appropriate.

- PD/TO/PJM may not use more than 60 days to negotiate.
- PJM may extend this phase beyond 60 days.
- Can file agreement unexecuted if an impasse is reached.



Draft Agreements in DocuTrack

#### DRAFT AGREEMENTS

PJM will send draft agreements via DocuTrack. TO/PD main contacts will receive email with link to draft agreements. Facilities Studies will be posted to the website.

- Edits and comments can be made directly in Word document.
- Access to documents will be limited to 20 Business Days.
- PD and TO can access documents at same time.
- All edits will be tracked via Tracked Changes in Word.


#### DRAFT GENERATION INTERCONNECTION AGREEMENT

Pursuant to Part VII, Section 314 of the PJM Open Access Transmission Tariff (Tariff), a draft Generation Interconnection Agreement (GIA) defining Project Developer's cost responsibility for the construction of the required Transmission Owner Interconnection Facilities, Network Upgrades, Distribution Upgrades, and Other Charges (as applicable), specifying Project Developer's interconnection rights, and obligating Project Developers to abide by the rules and procedures pertaining to generation in the PJM control area, is enclosed for review.

The scope and cost estimates provided in the draft GIA are based on the Facilities Study that is now posted on the PJM website. Facilities Studies provide a good-faith estimate of the engineering design work, the cost to be charged to Project Developer for Transmission Owner Interconnection Facilities, Network Upgrades, Distribution Upgrades, and Other Charges necessary to accommodate the Project, and time required to complete detailed design and construction of the facilities and upgrades.

The costs associated with the Facilities Study are being tabulated and a final statement/invoice will be submitted electronically from PJM detailing the balance within 120 days.



#### Please note:


- · The file will be checked out and locked while you are editing it


