### 1. Administration

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Morelli reviewed the agenda and called attention to the Anti-trust and Code of Conduct statements. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes from the 9/5 ERPIV meeting. The minutes were approved.

#### 2. Energy/Reserve Pricing Solution Components and Options Development

Ms. Rebecca Carroll reviewed the DASR changes to PJM's Energy and Reserve Pricing proposals that were discussed in full detail at the previous conference call meeting. Mr. Ray Fernandez reviewed the cost allocation solutions that PJM has developed. Mr. Adam Keech reviewed the Real Time changes to PJM's Energy and Reserve Pricing proposal. The previous solution of developing a 30 minute reserve market is no longer being pursued. PJM is now proposing a solution that is an extension of the current short term solution, with additional granularity.

#### 3. <u>Review Implementation Dates and Voting Timeline</u>

Ms. Morelli reviewed the solution implementation dates and voting timeline options that were brought up at the previous meeting. PJM requested feedback from stakeholders regarding their preferred path for voting knowing that all but the alternative cost allocation and two step demand curve pieces of the energy and reserve pricing solutions can be implemented prior to Winter 2014, with the remaining pieces being implemented in the Spring.
