Mr. Nagurney, on behalf of the Transmission Owners' Agreement – Administrative Committee (TOA-AC), discussed the process that the TOA-AC had used to develop a proposed solution. The proposal comprises adding a new page



on PJM.com to list the THEO, PLC and NSPL Methodology Inventory ("Inventory"), the responsibilities of all parties involved and the location of postings of related information on other sites. The proposal was presented was posted for the meeting, and was endorsed by the TOA-AC at its meeting held on 02/04/2014.
