## Endorsements

### 1. Manual 14D: Generator Operational Requirements

Vince Stefanowicz reviewed proposed revisions to Manual 14D: Generator Operational Requirements resulting from its periodic review. Following discussion, the committee **endorsed** the proposed manual revisions by acclamation with no objections and one abstention.

### 2. Clean Attribute Procurement Senior Task Force (CAPSTF) Sunset

Scott Baker discussed status of the CAPSTF activities and discussed the proposal to sunset of the group presented at the committee's last meeting. He noted that PJM had made the suggestion to sunset the group, and relayed that after further consideration of requests from several Members and other stakeholders, PJM was withdrawing the request to sunset the group at this time, pending results of the related state Forward Energy Attribute Market working group activities.

Paul Sotkiewicz, JPower USA, moved and David Scarpignato, Calpine, seconded that the CAPSTF be sunset. Following discussion, the motion to sunset **failed** in a sector-weighted vote with 1.70 in favor

The committee may be asked to approve the CAPSTF sunset at a future meeting.
