SOS Joint - eDART

eDART

- January 27, 2021 Enhancements
 - Nuclear Bus Voltage Limits
 - New Generator Outage Ticket Business Rules
 - Revisions to start date for active tickets
 - Revisions to reductions equal to ticket reduction (i.e. no change)
 - No duration tickets
 - Awareness Only Transmission Outage Tickets
 - eDART Dashboard

eDART Browserless Refresh Update

- Phase 1, transition to PJMCLI, is expected to be completed in early Q1 2021
- Phase 2 = Minor enhancements and fixes; expected to be completed Q2 2021
- An updated User's Guide and training will be provided for each phase
- The filetransfer.jar and legacy URLs will be retired in December 2021
