Administration (9:00-9:15)

- 1. Mr. Ken Seiler, PJM, called the meeting to order and Ms. Anisha Fernandes, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
- Ms. Anisha Fernandes reviewed the Agenda for the February 07, 2019 Planning Committee meeting. The Planning Committee approved the Agenda. An announcement was made to notify stakeholders of the scheduled Special PC M-3 Process Lessons Learned sessions (See Future Meeting Dates below).
- 3. Ms. Anisha Fernandes reviewed the draft minutes posted for the January 10, 2019 meeting and the Planning Committee approved the minutes.

- 4. Draft TO/TOP Matrix V13 Mr. Christopher Moran, PJM, presented the proposed changes to the TO/TOP Matrix. By vote of acclamation the Planning Committee provided a recommendation to the TOA-AC to approve the Draft TO/TOP Matrix V13 with 0 objections and 0 abstentions.
- Merchant Transmission Interconnection Process and Off-Shore Wind Ms. Sue Glatz, PJM, presented a Problem Statement to address potential areas of improvement to the merchant transmission interconnection process and off-shore wind projects. By vote of acclamation the Planning Committee endorsed this Problem Statement with 0 objections and 0 abstentions.

6. Interconnection Queue Process Improvements

Ms. Susan McGill, PJM, presented a Problem Statement to address process issues associated with deficiency cure periods at the end of the queue and identify potential areas of improvement. The proposed solution was also presented along with the Manual 14A revisions. By vote of acclamation the Planning Committee endorsed this Problem Statement and solution with 0 objections and 0 abstentions.

7. Manual 20 Updates

Mr. Jason Quevada, PJM, presented updates to Manual 20 Resource Adequacy Analysis. The Committee will be requested to endorse these updates at the next meeting.

8. ELCC Analysis of Intermittent Resources

Mr. Tom Falin, PJM, reviewed the proposed ELCC-based method to determine the UCAP value of wind and solar resources. A first read of all Manual 21 changes will be presented at the March 7th PC meeting.



9. Cost Commitment Status and Next Steps

Mr. Mark Sims, PJM, provided an update on the status and next steps for the Consideration of Cost Commitment for Evaluation of Competitive Transmission Proposals. <u>Issue Tracking: Cost Containment</u>

10. Network Model Alignment Initiative

Ms. Nicole Scott, Mr. Jason Sexauer and Mr. Kyle Clifford, PJM, presented accomplishments of the Network Model Alignment Initiative outlining the work performed and its relevance to Planning.

11. Dynamic Model Submission

Mr. Kyle Clifford and Mr. Tao Yang, PJM, provided an update on moving to generic dynamic models instead of user defined dynamic models.

12. FERC Order No. 845 Update

Ms. Susan McGill, PJM, provided a verbal update on Order 845. Ms. McGill mentioned that FERC has not yet issued an Order for Rehearing, and the deadline for filing would be 90 days after issuance. The changes to the reforms that are not subject to a rehearing request will be presented at the March 7th PC meeting and subsequent meetings, as needed.

13. RTEP Process Enhancements

(A) Mr. Aaron Berner, PJM, discussed the development of a problem statement related to the process for removal of a network upgrade, baseline, or Supplemental Project from the RTEPP.

(B) Ms. Sharon Segner, LS Power, reviewed when transmission projects will be removed from the RTEP models as proposed at the January 24, 2019 MRC meeting as friendly amendments.

14. Model Build Activity Update

Mr. Kyle Clifford provided an update regarding current model build activities, including the 2019 series MMWG/MOD-032 cases.

15. Value of Transmission Paper

Mr. Ken Seiler presented highlights from the Value of Transmission paper released in January.

16. Retirement of Lisle Remedial Action Scheme

Mr. Minh Nguyen, ComEd, presented information related to the retirement of the Remedial Action Scheme at Lisle substation.
