CIRs For ELCC Resources Overview

- CIRs for ELCC Resources approved at April 2021 PC
 - Ensure the appropriate application of CIRs to Generation
 Capacity Resources, with an emphasis on ELCC Resources
- Five defined solution design components:
 - CIR request policy
 - CIR verification, testing and retention policy
 - CIRs in ELCC methodology and AUCAP calculations
 - Implementation / effective dates
 - Transition mechanisms



August 23th Overview and Next Steps

- August 23, 2022 Meeting #19 included:
 - Discussion of six solution packages (focus on transition mechanisms)
 - LS Power replaced their Package E with Package E alternative 3
 - PJM added new Package H and new Package I
- Three remaining sessions scheduled:
 - September 6 review August 23 informational postings, take feedback and continue solution package discussions
 - September 23 provide updated information postings to include stakeholder feedback, continue solution package discussions and conduct non-binding poll
 - October 17 Continue solution package discussions and review results of nonbinding poll

Generator Deliverability Proposal Overview

- PJM is proposing modifications to each of the generator deliverability tests to better account for expected higher variability in dispatches under increased renewable penetration and better align planning and operations supporting operational flexibility.
- Over the past year, PJM provided stakeholders three educational sessions on the proposed modifications
- At the 8/9/2022 PC, stakeholders requested to keep the generator deliverability proposal approval process aligned with the work plan and approval process associated with changes for CIRs for ELCC Resources. PJM is targeting a second – first read at the November 1, 2022 PC.
