### 1. Attachment Q Updates

Hal Loomis, PJM, presented Attachment Q updates to restructure, clarify, update and slightly modify portions of Attachment Q as part of PJM's effort to update and make more consistent the PJM governing documents. PJM requested and received endorsement of the changes.

### 2. Financial Transmission Rights Undiversified Credit Requirement

Hal Loomis presented an updated analysis of, and recommendation regarding, the FTR Undiversified Credit Requirement Adder. PJM opened a poll after this meeting to assess stakeholder preferences for the different options. As mentioned in the CS meeting, the results of that poll were sent to the MIC to be used in the MIC endorsement process.
