1. Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the July 22, 2014 MSS meeting.

2. Update from MIC and MRC Meetings

Mr. Ray Fernandez provided an update on the August Market Implementation Committee (MIC) and July Markets and Reliability Committee (MRC) discussions regarding the Power Meter and InSchedule Deadlines and Capacity Charge Reconciliation topics. Both items were endorsed at the August MIC meeting. Draft manual and tariff changes related to the Power Meter and InSchedule Deadlines were reviewed with the group.

The implementation timing of the Capacity Charge Reconciliation proposal was also discussed and given the need for the RAA changes to be approved by the PJM Board of Managers, implementation would likely be targeted no earlier than the first quarter of 2015.

Both items will be brought to the August MRC and September MC meetings for further endorsement.

3. Settlement of Emergency Load Response and Emergency Energy Billing

Mr. Ray Fernandez reviewed the proposal to take into account the effect of Load Reconciliation data on a participant's Real Time Net Interchange calculation when determining their share of Emergency Energy charges or credits or Emergency Load Response charges. Due to timing constraints, the proposal calls for an adjustment to be made to the original Emergency Energy allocations after receipt of Load Reconciliation Data. Emergency Load Response charge allocation occurs after the submittal of Load Reconciliation data therefore would be included in the original billing.



Based on the polling results, an overwhelming majority (93%) of the 99 respondents supported the proposal. PJM will conduct an impact assessment to determine any necessary agreement and manual language changes and bring results to the September meeting.

4. FERC EQR Capacity Reporting

Ms. Susan Kenney reviewed the comments received regarding the reporting of Capacity information on the FERC EQR Report. Members requested the report to be updated to display one row per unique auction clearing price rather than one row per auction. No opposition was voiced to the suggested change. The report will be changed in the coming months to accommodate the request.

5. Miscellaneous Settlements Items

Mr. Ray Fernandez requested feedback regarding the use of PJM's MSRS Sandbox environment. The purpose of the system is to provide members a non-production environment for testing purposes; however it is not currently up to date. PJM is seeking feedback as to whether there is a participant need for the system or if it could be retired.
