## Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the December 16, 2020 MSS meeting.

## Working Issues

1. 2021 December Holiday Extensions

Sean Flamm, PJM, reminded the Subcommittee of the issue related to the December 2021 Holiday calendar. Sean detailed that consensus was achieved among the Subcommittee in regards to the desired non-PJM Holiday date in December 2021 and that the updated Holiday calendar will be available on [pjm.com](http://pjm.com).

2. Fast Start Initiative Updates

Ray Fernandez, PJM, discussed FERC's ruling on PJM's Fast Start initiative and provided updates on the settlement impacts related to the ruling.

3. MSRS Refresh Project

Sean Flamm discussed the status of the MSRS refresh project and reminded the Subcommittee of the release of the refreshed MSRS UI to the Train environment. Sean also detailed the target time for the refreshed MSRS UI to be deployed to the production environment. There was discussion around the inclusion of PKI certificates in the refreshed MSRS application, and it was detailed that PKI certificates would not be used in MSRS upon the release of the refreshed application. PKI certificates will be integrated later in 2021.
