#### Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the April 15, 2021 MSS meeting.

Sean Flamm, PJM, provided details on a Settlement C processed in the May 2021 invoice. There were adjustments for April 2019, May 2019, and June 2019 reconciliation data that affected the DAY area.

Natasha Holter, PJM, gave a reminder about upcoming Power Meter and InSchedule submission deadlines for the Independence Day holiday in July. ### Working Issues

#### 1. Manual 28 Revisions

Rebecca Stadelmeyer, PJM, reviewed revisions to Manual 28 as part of the bi-annual manual review and presented a First Read and Endorsement timeline for the revisions.

#### 2. MSRS Refresh Project

Sean Flamm, PJM, reviewed recent Production environment updates to the refreshed MSRS UI and provided a timeline for the retirement of the legacy MSRS UI. The legacy MSRS UI will be retired on July 14th, 2021.

#### Miscellaneous Settlements Items

Sean Flamm, PJM, reviewed the Production environment release timeline for FTR Report updates that were originally discussed at the February 2021 MSS. PJM will provide a communication with an exact Production environment release date.

Sean Flamm, PJM, reviewed recent updates to the PRD Credits billing line item and supporting MSRS report. The line item name was changed from LSE PRD Credit to PRD Credit and the supporting MSRS report name was changed from LSE PRD Credits to PRD Credits. The naming updates are effective for trade dates June 1st, 2021 and forward.
