  - Forfeitures are billed on a 1 month lag
  - Participants are provided FTR Forfeiture data upon request, no MSRS report
- 2 new MSRS reports will be created to provide participants with preliminary FTR Forfeiture billing data
  - Preliminary FTR Forfeiture Summary
  - Preliminary FTR Forfeiture Transactions
- Data is subject to change before billing
  - IMM Review of Forfeitures and reconciliation of PJM/IMM results
- Reports are provided as a courtesy. PJM will not immediately address inquiries on the preliminary data
