  - a. An eDART update in train and production expected for June 2024. The update includes the Transmission Facility Outages List which will provide a timestamp when a ticket was last evaluated by PJM and include the 'On'Time' flag. Additionally, enhancements to send email notification of approved restoration plans and current manual process will be retired.
  - b. There is an expected eDART release in August.
  - c. FERC Order 881 compliance is due July 2025.
