Dear Acting Secretary Reese:

On May 15, 2024, UGI Utilities, Inc. ("UGIU") made its Annual Update informational filing¹ in the above-captioned docket pursuant to its Formula Rate Implementation Protocols. The Annual Update is comprised of detailed calculations conducted through UGIU's cost-of-service formula rate as populated with data from UGIU's 2023 annual report on FERC Form 1, together with supporting data and workpapers.

UGIU has discovered that it inadvertently omitted the final page of the attachment to that filing, the populated Attachment H-8C (specifically "Attachment 9 – Depreciation Rates"). To correct this omission, UGIU is submitting this Errata, which contains a pdf of the full populated template, including Attachment 9. The calculation of UGIU's Annual Transmission Revenue Requirement remains unchanged from the May 15 informational filing.
